SECTION 1 CHAPTER 3 GUIDELINES FOR FIRST AID AND MEDICAL ASSISTANCE

Purpose

The Company has established the First Aid and Medical Care Program to:

- provide emergency medical care and first aid treatment for employees
- ensure the adequacy and availability of first aid supplies and equipment
- provide first aid and Cardiopulmonary Resuscitation (CPR) for employees
- provide training in first aid and CPR to employees
- guide Regions in complying with the first aid and medical care requirements of the Occupational Safety and Health Administration (OSHA)

Scope

The guidelines in this chapter apply to all Company locations.

Securing Medical Services

Purpose	This document outlines the responsibilities of management and the responsibilities of insurance carriers for providing access to medical services.
Responsibilities of management and safety	 Yard management and safety personnel must: utilize Axiom for all first aid (FA) type accidents establish a working relationship with medical providers engage the services of physicians to serve as consultants on matters of employee health secure appointments with a physician(s) close to each workplace, to provide emergency medical care for employees who may experience an occupational injury or illness ensure that emergency numbers are posted at the appropriate locations and by telephones If required, arrange transportation for injured personnel to the nearest hospital

Responsibilities of Workers Compensation Administration - insurance carrier	The workers compensation administrator or compensation insurance carrier will pay for the following if resulting from an occupational illness or injury: • examinations • laboratory work • x-rays • hospital and clinic services • physicians and surgeons fees • drugs and medicines • any other medical costs covered under the policy

Providing First Aid and CPR Training

Purpose	This document outlines the requirements for first aid training.	
Training requirements	IF medical attention is not available within 15 minutes of the workplace, THEN at least two employees on each location, and at least one employee at each office must be trained in first aid and CPR.	
Training courses	 Employees may take a formal training course in first aid and CPR from any of the following groups: American Red Cross American Heart Association Medic First Aid local fire departments Company certified Trainers 	
Refresher and supplementary training	 Employees who train in first aid and CPR must take courses frequently enough to ensure that they hold current certificates of training. Yard Management and HSE Coordinators will oversee supplementary training, such as: informal, periodically scheduled meetings to discuss first aid topics demonstrations during employee safety meetings

Maintaining First Aid Supplies and Equipment

PurposeThis document outlines the requirements for maintaining first aid supplies
In compliance with OSHA 1910.151(b) Subpart K

Locations of The Company shall provide standard First Aid Kits in the following locations:

- all Company-owned vehicles
- all permanent workplaces
- all rig sites in dog houses
- all VAP participant's vehicles

Determining the appropriate size first aid kit

IF the employee group has	THEN stock a
5 or fewer members,	10-unit first aid kit.
6 to 25 members,	16-unit first aid kit.
25 or more members,	30-unit first aid kit.

Stocking first aid kits

Yard Management and HSE Coordinators must:

- check first aid kits periodically to ensure that they are fully stocked
- ensure that first aid supplies are not out of date
- ensure first aid supplies are ordered as needed to replenish stock

Approving First Aid Kits

Purpose	This document outlines the requirements for approving both standard and non-standard kits.
Approval for first aid kits	OSHA 1910.151 appendix A requires physicians to approve the first aid supplies provided to employees. An Occupational Physician has approved items for use in 10-unit, 16-unit, and 30-unit sizes as outlined in "Stocking First Aid Kits".

Eye Wash Facilities

Purpose	This document outlines the requirements for maintaining eye wash facilities in compliance with OSHA 1910.151(c)		
Responsibilities of management and Safety	 Yard Management/HSE Coordinators shall : determine potentially hazardous locations and operations ensure the installation of federally required eye wash facilities ensure that the equipment is: in good operating condition at all times conveniently located in relation to hazards readily accessible for emergency use 		
Minimum Requirements	 One eye wash station (32oz. minimum) per rig/location prominently displayed One eye wash station in each shop/building with open access 		
Inspection of Eye Wash Station/Shower	Yard Management or designee will inspect eye wash/shower stations monthly. HSE Coordinators will inspect the eye wash/shower stations quarterly using the following procedure.		
	Step	Action	
	1	Visually check the general condition of the unit.	
	2	Check to ensure all components are present and functioning properly	
	3	Check for leaks, make sure eye wash has not expired	
	4	If maintenance is required, then yard management or designee	

will repair or replace.
